Treasurer's Report –Treasurer Powell gave his report which included the following from the Unaudited February 28, 2018 financial statements:

YTD Operations Revenue and Expenses as of February 28, 2018

OPS Total Income of \$ 319,124 vs. budgeted of \$ 303,020 - revenues are \$16,104 better than budgeted. OPS Total Expenses of \$255,550 vs. budgeted of \$265,332 expenses are \$9,781 under budget. Net income through February is \$63,574 before Depreciation and \$40,740 after Depreciation.

YTD Reserve Fund Revenue and Expenses as of February 28, 2018

Reserve income of \$35,747 vs. budgeted of \$44,550 reserve income was \$8,803 under budget. Actual expenses YTD were \$22,213 vs. budgeted of \$31,725. We are under budget by \$9,512. Summer projects have not started. Motion to accept: Director Powell, Second: Director Favero. Motion approved.
