**Treasurer's Report:** Mike Powell read letter from the Auditor. ATM Machine placed in Administrative Office, and with FOSCA Manager Millar's help we are now earning more interest.

**Management Report:** John Millar stated there are summaries of the budget that are available tonight and if anyone needs a complete copy they will be available in Administrative Office and posted on the bulletin board in Administration Office and also on web site. Homeowner asked if

wage increase for workers would have an impact on FOS employees. He replied all employees are above minimum wage so there would be no impact. Larry Wilkens, 8215 Ebola asked about the lightening expense in budget and if we had inquired about rebate, and wanted to know about tubes in overhead lights if they were LED, if we could use solar. He also wanted to know if the budget amount of \$30,000 for gate arms at main entrance included the cost of cards or whatever homeowners would use to enter. Manager Millar stated there was no increase in home owner dues. This coming year we will have increase in expense

**Proposal #2** “Resolved that any excess of membership income over membership expenses for the year ended December 31, 2016, shall be applied against the subsequent tax year member assessments as provided by IRS Revenue Ruling 70-604.”
